On behalf of Freymond Lumber Ltd., we are pleased to submit a complete application to the Township of Faraday for a Zoning By-law Amendment. Freymond Lumber Ltd. owns the lands located at 2287 Bay Lake Road, Part of Lots 51 and 52, Concession W.H.R in the County of Hastings. The Zoning By-law Amendment proposes to rezone the lands to permit a quarry.

The site is currently located within the Rural (RU) Zone and the Industrial (M) Zone. In order for a quarry to be permitted, an amendment is required to rezone the site to Extractive Industrial (MX). Additional site specific amendments are required to establish minimum setbacks from adjacent land uses.

Concurrent with this application, an Official Plan Amendment has been submitted to the County of Hastings and an Aggregate Resources Act application has been submitted to the Ministry of Natural Resources and Forestry. We kindly request that the applications be reviewed concurrently by the County of Hastings and the Township of Faraday, in order to coordinate review between each office, make efficient use of staff time and combine Public Meetings where possible.
